## TRADEMARK CONFIRMATORY ASSIGNMENT AGREEMENT

THIS TRADEMARK CONFIRMATORY ASSIGNMENT AGREEMENT (this "Agreement"), dated as of September 11, 2015, is made and entered into by and between Joe's Jeans Subsidiary Inc., a corporation organized under the Laws of the State of Delaware ("Transferor"), and Joe's Holdings LLC, a limited liability company organized under the Laws of the State of Delaware ("Transferee").

### RECITALS

WHEREAS, Joe's Jeans Inc., the parent of Transferor, Transferee and Sequential Brands Group, Inc. entered into an Asset Purchase Agreement, dated September 8, 2015 (the "Purchase Agreement"); and

WHEREAS, Transferor owns the trademark registrations and applications therefor and material unregistered trademarks set forth on Schedule A hereto (the "Transferred Trademarks"), and Transferor desires to assign the Transferred Trademarks to Transferee pursuant to this Agreement.

NOW THEREFORE, in consideration of the mutual agreements, provisions and covenants contained in this Agreement and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Transferor and Transferee hereby agrees as follows:

1. Defined Terms. Capitalized terms used herein but not otherwise defined herein shall have the meaning set forth in the Purchase Agreement.

2. Assignment and Assumption. To the extent that Transferor has not already done so by another document, Transferor hereby absolutely and unconditionally sells, assigns, transfers, conveys and delivers (and/or if already done so by another document, by this document confirms that is has sold, assigned, transferred, conveyed and delivered) to Transferee and its successors and assigns to have and to hold forever, all of such Transferor's right, title, benefit, privileges and interests in and to the Transferred Trademarks, including all applications, registrations and issuances therefor, any common law rights to such Transferred Trademarks, all goodwill associated therewith, and the right to sue and to collect damages and payments for claims of past, present and future infringement or misappropriation thereof.

3. Successorship. This Agreement shall be binding upon, inure to the benefit of, and be enforceable by Transferors and Transferee and their respective successors and permitted assigns. The covenants of Transferors and Transferee contained herein shall survive the execution and delivery of this Agreement.

4. EXCLUSION OF WARRANTIES. EXCEPT AS EXPRESSLY PROVIDED IN THE PURCHASE AGREEMENT, THERE ARE NO REPRESENTATIONS OR WARRANTIES, EXPRESS OR IMPLIED, REGARDING THIS AGREEMENT OR THE SUBJECT MATTER HEREOF, AND ANY REPRESENTATIONS OR WARRANTIES RELATING TO THIS AGREEMENT OR THE SUBJECT MATTER HEREOF ARE HEREBY DISCLAIMED.

5. General Provisions. Nothing contained in this Agreement supersedes, alters or modifies any of the obligations, agreements, covenants or warranties of any of the Transferors or Transferee under the Purchase Agreement (all of which survive the execution and delivery of this Agreement as provided and subject to the limitations set forth in the Purchase Agreement). In the event of any conflict between the terms of this Agreement and the terms of the Purchase Agreement, the terms of the Purchase Agreement shall control. This Agreement shall not be interpreted to broaden the scope of Transferee's rights with respect to the Transferred Trademarks beyond those rights provided in the Purchase Agreement. This Agreement may not be supplemented, altered, or modified in any manner except by a writing signed by all parties hereto.

6. Counterparts. This Agreement may be executed in counterparts, each of which shall be deemed an original, but all of which together shall be deemed to be one and the same agreement. A signed copy of this Agreement delivered by facsimile, e-mail or other means of electronic transmission shall be deemed to have the same legal effect as delivery of an original signed copy of this Agreement.

7. Governing Law. This Agreement shall be governed by and construed in accordance with the internal laws of the State of Delaware, without regard to its rules of conflict of laws.
