## RELEASE OF SECOND LIEN TRADEMARK SECURITY AGREEMENT

This Release Of Second Lien Trademark Security Agreement (this "Release") is dated as of February 25, 2016 with reference to that certain Second Lien Trademark Security Agreement dated as of February 20, 2009 (as amended, supplemented or otherwise modified from time to time, the "Security Agreement") among Panavision Imaging, LLC, a Delaware limited liability company, located at 6101 Variel Avenue, Woodland Hills, California 91367 (the "GRANTOR"), and Credit Suisse, as second lien collateral agent (in such capacity, the "Collateral Agent") for the lenders party thereto (the "Lenders").

WHEREAS, pursuant to the Security Agreement, Grantor granted to Collateral Agent for the benefit of the Lenders a security interest in Grantor's right, title or interest in or to all Trademark Collateral listed on Schedule 1, which was recorded with the United States Patent and Trademark Office on February 24, 2009 at Reel 3940 and Frame 0742;

WHEREAS, the Security Agreement has been terminated and Grantor is authorized by the Collateral Agent to terminate and release the security interest of the Collateral Agent in and lien on the Trademark Collateral; and


WHEREAS, Grantor desires to record this instrument to evidence termination of the security interest in the Trademark Collateral.

NOW, THEREFORE, Grantor hereby terminates, releases, and discharges fully, Collateral Agent's security interest in and lien on the Trademark Collateral (including without limitation the trademarks listed on Schedule 1 hereto) as granted pursuant to the Security Agreement, and any rights Collateral Agent may have in the Trademark Collateral are hereby reconveyed, transferred, and assigned to each Grantor, as applicable, without recourse, representation or warranty of any kind, and any right, title or interest of Collateral Agent in the Trademark Collateral shall hereby cease and become void.
