CLAUSES


For good and valuable consideration, receipt and sufficiency of which the Assignor specifically acknowledges:

Assignor does not reserve or retain any right, title, or interest in the Trademarks. Assignor acknowledges and agrees that the Trademarks constitute the sole and exclusive property of Assignee.


This Assignment shall be binding upon and inure to the benefit of Assignee, its successors and assigns.
