## TRADEMARK ASSIGNMENT AGREEMENT

This TRADEMARK ASSIGNMENT AGREEMENT (this "Assignment"), dated as of February 26, 2016, is by and between, Canterbury Preparatory School, Inc. (the "Buyer"), and Canterbury Intellectual Property, LLC (the "Seller").

Seller has all right, title, and interest in and to the trademark and service mark listed on Schedule A attached hereto and made a part hereof, together with the goodwill associated with such trademarks and services marks and all applications, registrations, renewals, and extensions thereof (collectively, the "Mark"); and

Seller desires to assign to the Buyer all of the Seller's right, title, and interest in and to the Mark.

**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Seller hereby agrees as follows:

**Section 1. Assignment.** The Seller hereby irrevocably grants, transfers, assigns, and conveys to the Buyer all Seller's right, title, and interest in and to the Mark, together with the goodwill of the business symbolized thereby.

**Section 2. Further Assurances.** The Seller hereby agrees, without further consideration therefor, to execute, acknowledge, and deliver, or cause to be executed, acknowledged, and delivered, such further instruments and documents and to perform such further acts as may be reasonably requested by the Buyer to effectuate more fully the transactions contemplated by this Assignment.

**Section 3. Authorization to Record; Power of Attorney.** The Seller authorizes the appropriate authority or authorities whose duty it is to record trademark registrations, applications, and title thereto, to record the Mark and title thereto as the property of the Buyer, its successors and assigns in accordance with the terms of this Assignment and at the Buyer's expense. The Seller hereby constitutes and appoints the Buyer as its true and lawful attorney-in-fact, with full power of substitution in the Seller's name and stead, to take any and all steps, including proceedings at law, in equity, or otherwise, to execute, acknowledge, and deliver any and all instruments and assurances solely as necessary in order to vest or perfect the aforesaid rights and causes of action more effectively in the Buyer or to protect the same or to enforce any claim or right of any kind with respect thereto. The Seller hereby declares that the foregoing power is coupled with an interest and as such is irrevocable.

**Section 4. Successors and Assigns.** This Assignment will be binding upon the Seller and its respective successors and assigns and will inure to the benefit of the Buyer and its successors and assigns.

**Section 5. Governing Law.** This Assignment shall be governed by and construed and interpreted in accordance with the substantive laws of the State of Kansas, without giving effect to any conflicts of law rule or principle that might result in the

application of the laws of another jurisdiction.


**Section 6. Counterparts.** This Assignment may be executed in one or more counterparts, and each of which shall constitute an original instrument, but all such together shall constitute one and the same agreement. Signature by facsimile or emailed .PDF is hereby authorized.

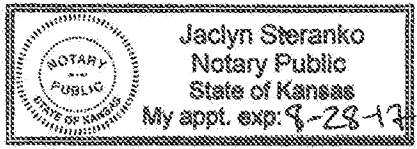
