23 California Code of Civil Procedure, § 187 by plaintiff and judgment creditor, Golden
24 Springs Development Company, LLC ("Golden Springs") to amend its February 8, 2013,
25 judgment against Wham-O, Inc., a Delaware corporation in the above-captioned case to
26 add the following entities as judgment debtors:

- 27 1. Wham-O Marketing, Inc., a Delaware corporation;
28 2. Wham-O Holding, Ltd., a Hong Kong limited company;

- 1 3. Wham-O Australia Pty Limited, an Australian proprietary limited company;
- 2 4. Wham-O Asia, Ltd, a Hong Kong limited company; and
- 3 5. Wham-O International, Ltd., a Hong Kong limited company.

4 On July 2, 2015, the Court (1) granted the motion as to Wham-O Marketing, Inc., a
5 Delaware corporation, (2) denied without prejudice the motion as to Wham-O Asia, Ltd, a
6 Hong Kong limited company and (3) continued the motion as to Wham-O Holding, Ltd., a
7 Hong Kong limited company and Wham-O International, Ltd., a Hong Kong limited
8 company to September 17, 2015.

9 On September 17, 2015, Golden Springs appeared at the hearing through its
10 attorney, Mark Rosenbaum, Esq. of Wolf, Rifkin, Shapiro, Schulman & Rabkin, LLP.

11 John Arai Mitchell, Esq. specially appeared for Wham-O Holding, Ltd., a Hong
12 Kong limited company, Wham-O Australia Pty Limited, an Australian proprietary limited
13 company and Wham-O International, Ltd., a Hong Kong limited company.

15 **WHEREAS** the original parties to this action are Golden Springs and Wham-O,

5 IT IS HEREBY ORDERED AS FOLLOWS:

11 For the avoidance of doubt, said additional judgment debtors are liable to Golden
12 Springs for all post-judgment interest, costs, and attorneys' fees (and would receive credit
13 for any payments on the judgment) the from February 8, 2013, to the present, to the same
14 extent that Wham-O, Inc., a Delaware corporation is liable to Golden Springs for said
15 amounts.
