## RELEASE OF TRADEMARK

THIS RELEASE OF TRADEMARK is dated as of February 29, 2016 by Bank of America, N.A., as Agent (f/k/a LaSalle Business Credit, Inc.) (the "Agent").

WHEREAS, Behlen Mfg. Co., BMC Transportation Company, Behlen International, Inc., Behlen Engineered Plastics, Inc. (formerly Agri-Engineering, Inc.), Behlen Asia, Inc. and Inland Southern Corporation (collectively, the "Grantors") and Agent entered into that certain Trademark, Patent and Copyright Security Agreement dated as of November 30, 2001 (the "Security Agreement");

WHEREAS, to secure the satisfactory performance and payment of all of the Obligations of the Grantors (as such term is defined in the Security Agreement) the Grantors granted Agent a security interest ("Grant of Security Interest in Trademarks and Patents") in certain trademarks, trademark registrations, trademark applications, patents and any and all good will associated therewith, including, without limitation, the Trademark listed on Schedule I attached hereto (the "Trademark");

WHEREAS, Agent recorded the Grant of Security Interest in Trademarks and Patents on March 1, 2002 at Reel 2461, Frame 0434 in the United States Patent and Trademark Office; and

WHEREAS, the Grantors have requested that Agent release its security interest in the Trademark.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Agent hereby agrees as follows:

Agent hereby fully releases and terminates its security interests in and lien on the Trademark, including:

(a) all of the Grantors' now existing or hereafter acquired right, title and interest in and to the Trademark which is now filed with the U.S. Patent and Trademark Office, any similar office or agency of any state, territory or possession of the United States or Canada or any similar office or agency of any other country or used in the United States, any state, territory or possession thereof including, without limitation, Puerto Rico, or any other country, and (i) any renewals thereof, (ii) all income, royalties, damages and payments now and hereafter due or payable with respect thereto, including, without limitation, payments under all licenses entered into in connection therewith and damages and payments for past or future infringements thereof, (iii) the right to sue for past, present and future infringements thereof, (iv) all documents, packages, prints and labels on which the Trademark has appeared and all designs and general intangibles of a like nature, and (v) all rights corresponding thereto throughout the world;

(b) the goodwill of the Grantors' business connected with or symbolized by the Trademark; and

(c) any and all of the proceeds of any of the foregoing, including, without limitation, any claims by the Grantors against third parties for infringement of the Trademark or of any license with respect thereto.


