**TERMINATION AND RELEASE OF SECURITY INTEREST IN PATENTS AND
TRADEMARKS**

This **TERMINATION AND RELEASE OF SECURITY INTERESTS IN PATENTS AND TRADEMARKS** (this "*Termination and Release*") is granted as of February 29, 2016 by **WELLS FARGO BANK, NATIONAL ASSOCIATION** ("*Wells Fargo*"), in favor of **PETEDGE, INC.**, a Massachusetts corporation (the "*Company*").

WHEREAS, the Company requests that Wells Fargo hereby terminate, release and discharge fully its security interests in and liens on all right, title and interest of the Company in, to and under all of the trademarks, trademark applications, patents and patent described in the Agreement (collectively, the "*Patents and Trademarks*") as herein provided; and

WHEREAS, the Company requests that Wells Fargo provide a document suitable for recording in the United States Patent and Trademark Office to evidence the release of its security interests in and liens on the Patents and Trademarks as herein provided.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Wells Fargo hereby:


1. terminates the Agreement and releases, terminates and discharges all liens and security interests in the Company's right, title and interest in, to and under the Patents and Trademarks including those Patents and Trademarks identified in Schedule 1 hereto; and
2. agrees that it shall, at the Company's sole cost and expense, upon the Company's or its respective successor's or assign's, reasonable request, execute, acknowledge and deliver to Company all further releases and other documents, and take all other actions necessary or reasonably desirable for the release of such security interest.
