
**DECLARATION OF STEPHANIE B. TILLMAN**

On September 8, 2015, pursuant to a stock purchase agreement between Flowers Foods, Inc., Flowers Bakeries, LLC, Alpine Valley Bread Company, and the two shareholders of Alpine Valley Bread Company, Flowers Bakeries, LLC became the owner of Reg. No. 2257178 of the ALPINE VALLEY mark and application Serial No. 86497457 to register the ALPINE VALLEY SUPER GRAINS marks. Pursuant to the same stock purchase agreement, Flowers Bakeries, LLC became the successor to the portions of the business of Alpine Valley Bread Company relating to the ALPINE VALLEY and ALPINE VALLEY SUPER GRAINS marks.
