TERMINATION OF SECURITY INTEREST IN TRADEMARKS

**THIS TERMINATION OF SECURITY INTEREST IN TRADEMARKS** (this "Termination"), is dated as of March 1, 2016 and is made by **GOLUB CAPITAL MARKETS LLC (f/k/a GCI CAPITAL MARKETS LLC)**, a Delaware limited liability company, as administrative agent for the Lenders (in such capacity, together with its successors and assigns, the "Administrative Agent") under the Trademark Security Agreement (as defined below). Capitalized terms used but not defined herein shall have the same meanings assigned to such terms in the Trademark Security Agreement (as defined below).

WHEREAS, pursuant to that certain Trademark Security Agreement dated as of May 18, 2015 made by **IMAGING SCIENCE & SERVICES, INC.**, an Ohio corporation, with an address of 200 Ballardvale Street, 4<sup>th</sup> Floor, Wilmington, Massachusetts 01887 (the "Grantor") in favor of the Administrative Agent (the "Trademark Security Agreement"), the Grantor granted to the Administrative Agent a security interest (the "Security Interest") in all of Grantor's right, title and interest in, to and under its owned or thereafter acquired Trademarks, including those set forth on the attached Schedule A, and all of the goodwill of the business associated with the Trademarks (the "Trademark Collateral"); and

WHEREAS, the Trademark Security Agreement was recorded in the Trademark Division of the United States Patent and Trademark Office on May 19, 2015, at Reel 5519 and Frame 0178; and

WHEREAS, the Grantor has requested, and the Administrative Agent has agreed, to provide a document suitable for recording in the United States Patent and Trademark Office evidencing and effecting the release, relinquishment and discharge of its Security Interest in the Trademark Collateral (the "Released Collateral").

NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, the Administrative Agent does hereby, in each case, without recourse, representation or warranty of any kind whatsoever, (a) terminate the liens and Security Interest created under the Trademark Security Agreement and in the Released Collateral, (b) release its Security Interest in the Released Collateral, (c) discharge any and all rights, title and interest it has in the Released Collateral, and (d) assign, transfer and convey to Grantor any interest in such intellectual property, including the Security Interest.
