RELEASE OF SECURITY INTEREST IN TRADEMARKS, dated as of September 16, 2015 (this "*Release*"), by CREDIT SUISSE AG, as Collateral Agent (in such capacity, the "*Agent*") in favor of INTERNETWORK PUBLISHING CORPORATION, a Florida corporation, ORBITZ, LLC, a Delaware limited liability company, ORBITZ AWAY LLC, a Delaware limited liability company, ORBITZ FOR BUSINESS, INC., a Delaware corporation, ORBITZ WORLDWIDE, LLC, a Delaware limited liability company, and TRIP NETWORK, INC., a Delaware corporation (each, an "*Obligor*" and collectively, the "*Obligors*"). Capitalized terms used herein and not otherwise defined shall have the meanings assigned to such terms in the Credit Agreement or the IP Security Agreement, as applicable, referred to below.

A. Reference is made to (i) the Credit Agreement dated as of March 25, 2013 (as amended, amended, supplemented or modified from time to time, the "*Credit Agreement*"), among Orbitz Worldwide, Inc. (the "*Borrower*"), the Lenders party thereto from time to time, Credit Suisse AG, Cayman Islands Branch, as Administrative Agent, Collateral Agent, L/C Issuer and Swing Line Lender, JPMorgan Chase Bank, N.A., as L/C Issuer and SunTrust Bank, as L/C Issuer, (ii) the Intellectual Property Security Agreement dated as of March 25, 2013 (as amended, supplemented or otherwise modified from time to time, the "*IP Security Agreement*") among the Borrower, certain Subsidiaries of the Borrower identified therein and the Agent, and (iii) the Grant of Security Interest in Patent and Trademarks Rights effective as of March 25, 2013, among the Obligors and the Agent (the "*Patent and Trademark Security Agreement*").

B. Pursuant to the Patent and Trademark Security Agreement, each Obligor granted to the Agent, for the benefit of the Secured Parties, a security interest in all right, title and interest of the Obligors in, among other property, the Trademarks set forth on Schedule I hereto (the "*Trademark Collateral*"), and pursuant to the Patent and Trademark Security Agreement, such security interest was recorded with the United States Patent and Trademark Office on May 3, 2013 at Reel/Frame 5020/0340.

C. In connection with the repayment of all Indebtedness and the termination of all Commitments under the Credit Agreement, and the release of security interests in connection therewith, each Obligor has informed the Agent of their desire to obtain the release of all right, title and interest of the Agent, the Secured Parties and each other grantee or beneficiary in and to the Trademarks granted under the IP Security Agreement.

Accordingly, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Agent, on behalf of the Secured Parties, does hereby terminate, release, relinquish and discharge its security interest in the
