WHEREAS, Assignee is desirous of acquiring the Marks;


NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged:

Assignor does hereby sell, assign, and transfer to Assignee all of Assignor's rights, title and interest in and to the Marks.


