TRADEMARK ASSIGNMENT

THIS TRADEMARK ASSIGNMENT (this "Assignment"), is made as of the 11 day of December 2015, by Angles BeautyCare Group, Inc., a California corporation ("Seller"), in favor of Beauty Concept Group, LLC, a California limited liability company ("Buyer"), with reference to the following:

A. Seller is owns the trademarks and service marks, including applications for registration thereof (collectively the "Trademark Applications") listed on Exhibit A attached hereto (collectively the "Marks").

B. Buyer, on the one hand, and Seller, on the other hand, are parties to that certain Asset Purchase Agreement, dated concurrently herewith (the "Asset Purchase Agreement"), with respect to Seller's sale to Buyer of substantially all of the assets of Seller, including the Marks.

C. Seller desires to confirm the assignment of the Marks for purposes of filing the same with the United States Patent and Trademark Office (the "PTO").

NOW, THEREFORE, Seller agrees on behalf of Buyer as follows:

1. Assignment of Marks. For good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Seller hereby transfers, conveys and assigns to Buyer all of Seller's right, title and interest in, to and under (a) the Marks; (b) the goodwill associated with the Marks; and (c) all rights to proceeds of the foregoing, including without limitation any claim by Seller against third parties for past, present or future infringement of the Marks.

2. Trademark Applications. Seller hereby authorizes and requests the PTO to issue the certificate of registration in respect of the Trademark Applications to Buyer for its sole use, and for the use of its legal representatives and assigns, to the full end of the term for which such registration may be granted, as fully and entirely as the same would have been held by Seller had this assignment not been made.
