## RELEASE OF TRADEMARK AND TRADEMARK APPLICATION SECURITY INTERESTS IN JOINDER, ASSUMPTION AND FIRST AMENDMENT TO INTELLECTUAL PROPERTY SECURITY AGREEMENT

This RELEASE OF TRADEMARK AND TRADEMARK APPLICATION SECURITY INTEREST IN JOINDER, ASSUMPTION AND FIRST AMENDMENT TO SECURITY INTEREST IN INTELLECTUAL PROPERTY SECURITY AGREEMENT (this "Release"), dated as of February 23, 2016, is made by Silicon Valley Bank (the "Bank").
