**RELEASE OF TRADEMARK AND TRADEMARK APPLICATION SECURITY
INTERESTS IN JOINDER, ASSUMPTION AND SECOND AMENDMENT TO
INTELLECTUAL PROPERTY SECURITY AGREEMENT**

This **RELEASE OF TRADEMARK AND TRADEMARK APPLICATION SECURITY INTERESTS IN JOINDER, ASSUMPTION AND SECOND AMENDMENT TO INTELLECTUAL PROPERTY SECURITY AGREEMENT** (this "**Release**"), dated as of February 23, 2016, is made by Silicon Valley Bank (the "**Bank**").

WHEREAS, TeleCommunication Systems, Inc., a Maryland corporation, Solvern Innovations, Inc., a Maryland corporation, Networks in Motion, Inc., a Delaware corporation, microDATA GIS, Inc., a Vermont corporation, and microDATA, LLC, a Maryland limited liability company (collectively "**Debtors**"), and the Bank entered into a certain Joinder, Assumption and Second Amendment to Intellectual Property Security Agreement, dated as of July 6, 2012 (the "**Trademark Security Agreement**");

WHEREAS, pursuant to the Trademark Security Agreement, Debtors granted a security interest in certain Trademarks and Trademark Applications owned by Debtors, including, without limitation, those set forth on Schedule I attached hereto (the "**Trademark Collateral**");

WHEREAS, the Trademark Security Agreement was recorded in the U.S. Patent and Trademark Office on July 17, 2012, at Reel Number 004822 and Frame Number 00930; and

WHEREAS, Debtors have paid or otherwise satisfied all of their outstanding indebtedness to the Bank.

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged the Bank hereby terminates the Trademark Security Agreement, and hereby terminates, cancels, and releases, without representation, recourse or warranty whatsoever, all of its security interest in the Trademark Collateral, whether granted pursuant to the Trademark Security Agreement or any other agreement or document delivered in connection with the Trademark Security Agreement.

The Bank agrees, at Debtors' expense, to cooperate with Debtors and to provide Debtors, their successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by Debtors to more fully and effectively effectuate the purposes of this Release.


