TRADEMARK ASSIGNMENT

1. ASSIGNOR hereby assigns to ASSIGNEE the TRADEMARK set forth in Schedule A attached hereto **TOGETHER** with the good will of ASSIGNOR associated with said TRADEMARK as used by ASSIGNOR, **TO HOLD** the same unto ASSIGNEE, and its assignees, absolutely.
2. ASSIGNOR hereby consents to ASSIGNEE being entered on the Register of Trademarks of the country or countries corresponding to the registration appearing on the attached Schedule A as the subsequent proprietor of the TRADEMARK.
3. To the extent necessary, ASSIGNOR will provide whatever cooperation and documentation are necessary, at the request and expense of ASSIGNEE, to allow ASSIGNEE to record

its interest in and to the TRADEMARK in the country or countries corresponding to the registrations appearing on the attached Schedule.


