- (i) in and to causes of action and enforcement rights for the Trademark Rights including all rights to pursue damages, injunctive relief and other remedies for past and future infringement of the Trademark Rights, and
- (ii) to apply in any or all countries of the world for trademark registration, or other governmental grants for the Trademark Rights, including without limitation under the Paris Convention, the Trademark Law Treaty, the Madrid Protocol, or any other convention, treaty, agreement or understanding.

Assignor also hereby authorizes the respective trademark office or governmental agency in each jurisdiction to register any and all trademarks which may be granted upon any of the Trademark Rights in the name of Assignee, as the assignee to the entire interest therein.

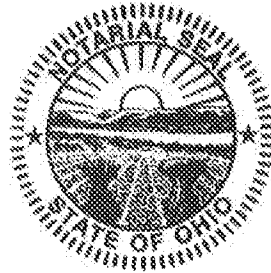

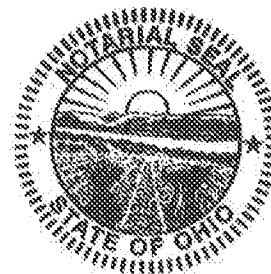
