**RELEASE OF SECURITY INTEREST IN TRADEMARKS**

**THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS** (this “*Release*”) is made as of March 7, 2016, granted by CREDIT SUISSE AG, CAYMAN ISLANDS BRANCH, in its capacity as collateral agent (in such capacity, including any successor thereto, the “*Collateral Agent*”) pursuant to that certain Guarantee and Collateral Agreement, dated as of July 22, 2011 (as amended, modified or otherwise supplemented from time to time, the “*Security Agreement*”) among CAMBER CORPORATION, a Delaware corporation, (“*Borrower*”), the Subsidiary Guarantors party thereto from time to time and the Collateral Agent, in favor of the Borrower, I2S, Inc. and Camber Defense Security and Systems Solutions, Inc. Capitalized terms used herein have the meanings attributed thereto in the Security Agreement unless otherwise defined herein.

**WHEREAS**, the Borrower, I2S, Inc., a Delaware corporation, and Camber Defense Security and Systems Solutions, Inc., a Texas corporation (collectively with Borrower, the “*Grantors*”) and the Collateral Agent entered into that certain Trademark Security Agreement, dated as of July 22, 2011 (the “*Trademark Security Agreement*”), whereby Grantors pledged to the Collateral Agent, its successors and assigns, for the ratable benefit of the Secured Parties, and granted to the Collateral Agent, its successors and assigns, for the ratable benefit of the Secured Parties, a security interest in all right, title or interest in or to any and all of the following assets and properties then owned or at any time thereafter acquired by such Grantors or in which such Grantors then had or at any time thereafter may have acquired any right title or interest (collectively, the “*Released Trademarks*”):

- (a) trademarks, service marks, trade names, corporate names, company names, business names, fictitious business names, trade styles, trade dress, logos, Internet domain names, other source or business identifiers, and designs, now existing or hereafter adopted or acquired, all registrations and recordings thereof, and all registration and pending applications filed in connection therewith, including registrations and pending applications in the United States Patent and Trademark Office (or any successor office) or any similar offices in any State of the United States or any other country or any political subdivision thereof, and all extensions or renewals thereof, including those listed on Exhibit A hereto;
- (b) all goodwill associated therewith or symbolized thereby; and
- (c) all Proceeds and products of any and all of the foregoing, all Supporting Obligations and all collateral security and guarantees given by any Person with respect to any of the foregoing;

**WHEREAS**, the Trademark Security Agreement was recorded in the U.S. Patent and Trademark Office on July 25, 2011, at Reel 4590, Frame 0285; and

**WHEREAS**, the Collateral Agent wishes to release, discharge, relinquish, terminate and dissolve any and all security interests, liens and encumbrances in and to the

Released Trademarks;

**NOW, THEREFORE**, for good and valuable consideration including the satisfaction of all obligations, indebtedness and liabilities secured by the Released Trademarks pursuant to the Trademark Security Agreement, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Release, the Collateral Agent hereby states as follows:

1. Release of Security Interest. The Collateral Agent hereby releases, discharges, relinquishes, terminates, and dissolves its security interest in the Released Trademarks, and any right, title or interest of the Collateral Agent in such Released Trademarks shall hereby cease and become void, in each case, without recourse to or representation or warranty by the Collateral Agent..

2. Further Assurances. The Collateral Agent agrees to execute and deliver to Grantors any and all further documents and instruments, and do any and all further acts which Grantors (or their agents or designees) reasonably request (at Grantors' sole cost and expense) in order to confirm this Release. Any execution and delivery of documents or instruments pursuant to this Section 2 shall be without recourse to or representation or warranty by the Collateral Agent.

3. Recordation of Release. The Collateral Agent hereby authorizes Grantors or Grantors' authorized representatives to record this Release with the United States Patent and Trademark Office.

4. Applicable Law. This Release shall be construed in accordance with and governed by the laws of the State of New York.


