TERMINATION OF INTELLECTUAL PROPERTY SECURITY AGREEMENT

THIS TERMINATION OF INTELLECTUAL PROPERTY SECURITY AGREEMENT is made as of March 4, 2016 by the undersigned and is a termination of that certain Short-Form IP Security Agreement dated December 5, 2006 (the "*Original Security Agreement*") and that certain Amended and Restated Short-Form IP Security Agreement dated May 8, 2008 (the "*Second Security Agreement*", together with the Original Security Agreement, the "*Security Agreement*"), by and between FOX RESTAURANTS CONCEPTS LLC, an Arizona limited liability company ("*Grantor*") and GE CAPITAL US HOLDINGS, INC., a Delaware corporation ("*Lender*"), assignee of General Electric Capital Corporation, pursuant to those certain Development Line of Credit Loan and Security Agreements dated as of December 5, 2006, releasing all security interests of Lender in the Intellectual Property (as defined in the Security Agreement). Capitalized terms not otherwise defined herein shall have the meanings ascribed thereto in the Security Agreement.

Recitals

WHEREAS, Lender recorded the Original Security Agreement in the United States Patent and Trademark Office on December 7, 2006 at **Reel/Frame No. 3439/0375**, and the Second Security Agreement on May 19, 2008 at **Reel/Frame No. 3779/0653**;

WHEREAS, the Security Agreement included reference to the Intellectual Property identified in *Schedule I*, attached hereto and made part hereof (the "*Released Intellectual Property*"); and

WHEREAS, Lender desires to terminate and release its security interest in the Intellectual Property;

NOW, THEREFORE, Lender by these presents does hereby release its security interest in the Intellectual Property as set forth in the Security Agreement.

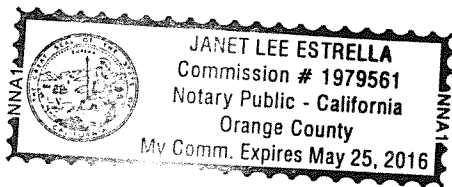
