TERMINATION OF TRADEMARK SECURITY AGREEMENT

THIS TERMINATION OF TRADEMARK SECURITY AGREEMENT (this "Agreement") is made effective this 8 day of March, 2016 (the "Effective Date") by and between **UNDERLINE COMMUNICATIONS, LLC**, a New York limited liability company ("Underline"), and **MONROE CAPITAL MANAGEMENT ADVISORS LLC** ("Monroe"). All capitalized terms not otherwise defined in this Agreement shall have the meanings prescribed to such terms set forth in the Security Agreement (as defined below).

WHEREAS, Underline executed and delivered that certain Trademark Security Agreement in favor of Monroe as of February 23, 2014 (the "Security Agreement"), recorded at reel/frame 5465/0057, on February 24, 2014; and

WHEREAS, the parties desire to terminate the Security Agreement effective immediately.

NOW THEREFORE, the parties agree as follows:

1. Termination of Security Agreement. The Security Agreement is hereby terminated in its entirety and is deemed to be null and void and of no further effect. Except as set forth in this Agreement, as of the date of this Agreement, the parties shall have no rights, duties, obligations, or liabilities arising under the Security Agreement.

2. Release of Security Interest. Monroe and the Lenders, through their Agent, Monroe, hereby release any and all liens, encumbrances, liabilities, or security interests granted by Underline to Monroe or the Lenders, or both.

3. Binding Effect. This Agreement shall be binding upon and inure to the benefit of the parties and their successors and assigns.

4. Governing Law. This Agreement shall be governed by and construed in accordance with the laws of the State of Illinois without regard to any applicable principles of conflicts of laws.

5. Counterparts. This Agreement may be executed in one or more counterparts, each of which shall be deemed an original, but all of which together shall constitute one and the same instrument. This Agreement may be executed and delivered by facsimile transmission or electronic mail, and a facsimile or electronic version of this Agreement or of a signature of a party will be effective as an original.




