TERMINATION OF SECURITY INTEREST IN TRADEMARKS

THIS TERMINATION OF SECURITY INTEREST IN TRADEMARKS (this "Termination"), is dated as of March 2, 2016 and is made by **CRESCENT DIRECT LENDING, LLC**, a Delaware limited liability company, as administrative agent and collateral agent for the Lenders (in such capacity, together with its successors and assigns, the "Agent") under the Trademark Security Agreement (as defined below). Capitalized terms used but not defined herein shall have the same meanings assigned to such terms in the Trademark Security Agreement (as defined below).

WHEREAS, pursuant to that certain Trademark Security Agreement dated as of May 18, 2015 made by **ENVIRONMENTAL CONDITIONING, LLC**, a Delaware limited liability company, with an address of 3636 E. Anne Street, Suite A, Phoenix, Arizona 85040 (the "Grantor") in favor of the Agent (the "Trademark Security Agreement"), the Grantor granted to the Agent a security interest in all of Grantor's right, title and interest in, to and under its owned or thereafter acquired Trademarks, including those set forth on the attached Schedule A (the "Trademark Collateral"); and

WHEREAS, the Trademark Security Agreement was recorded in the Trademark Division of the United States Patent and Trademark Office on May 20, 2015, at Reel 5520 and Frame 0576; and

WHEREAS, the Grantor has requested, and the Agent has agreed, to provide a document suitable for recording in the United States Patent and Trademark Office evidencing and effecting the release, relinquishment and discharge of its Security Interest in the Trademark Collateral (the "Released Collateral").

NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, the Agent does hereby, in each case, without recourse, representation or warranty of any kind whatsoever, (a) terminate the liens and Security Interest created under the Trademark Security Agreement and in the Released Collateral, (b) release its Security Interest in the Released Collateral, and (c) discharge any and all rights, title and interest it has in and the Security Interest granted to the in the Released Collateral.
