**TERMINATION AND RELEASE OF
SECURITY INTEREST IN TRADEMARKS**

This TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS (this "*Release*") is entered into by and between SILICON VALLEY BANK (the "*Secured Party*") and LIGHTHOUSE PRACTICE MANAGEMENT GROUP, INC., a Delaware corporation having its principal offices at 330 West 34th Street, 18th Floor, New York, NY 10010 (the "*Company*").

WHEREAS, the Company executed and delivered an Intellectual Property Security Agreement dated as of April 2, 2013 (as the same may be amended of record from time to time, the "*Security Agreement*"), which was recorded with the United States Patent and Trademark Office on April 3, 2013, pursuant to which the Company granted a security interest to the Secured Party in certain collateral;

WHEREAS, the Company and the Secured Party entered into a Supplement to Intellectual Property Security Agreement dated as of February 6, 2015 (the "*Supplement*"), pursuant to which the Company, by reference to the Security Agreement, granted a security interest to the Secured Party in additional Trademarks (as defined in the Supplement), including those listed on Exhibit A, a true and correct copy of which was recorded by the United States Patent and Trademark Office on February 6, 2015 at Reel 5455, Frame 0203; and

WHEREAS, the Secured Party now desires to terminate and release the entirety of its security interest in the Trademarks.

NOW, THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged, the Secured Party hereby:


1. terminates, releases and reassigns to the Company any and all liens, security interests, right, title and interest of the Secured Party pursuant to the Supplement in the Trademarks, without recourse or representation or warranty, express or implied, and any right, title or interest of the Secured Party in and to the foregoing shall hereby cease and become void;
2. authorizes and requests the Commissioner Trademarks of the United States of America to note and record the termination and release of security interest hereby given; and
3. agrees to duly execute, acknowledge, procure, and deliver any further documents or instruments and to do such other acts as may be reasonably necessary to effect the termination and release of security interest contemplated hereby.
