## This Confirmatory Deed – United States of America

BETWEEN the following parties:

**ELECTROLUX CONTRACTING AB**, a Swedish company,  
of S:t Goransgatan 143, Stockholm 10545, Sweden  
(the "Assignor");

and

**AKTIEBOLAGET ELECTROLUX**, a Swedish company,  
of S:t Goransgatan 143, Stockholm 10545, Sweden  
(the "Assignee").

### Recitals

- A. By agreement dated 13 November 2015 the Assignor assigned to the Assignee all right, title and interest to the registered trade marks referred to in Schedule 1 (collectively referred to as the "Trade Marks"), including the goodwill and trade dress associated (referred to as the "Trade Dress") with the Trade Marks, and the goodwill of the business relating to the stoves, cookers, microwaves, ovens for cooking, electric toaster ovens, domestic cooking ovens, barbecues and grills and parts and fittings for all of the aforementioned goods; gas, electric and solid fuel stoves for cooking or heating; gas cooking burners for camping; deep fat fryers; microwave ovens for cooking and heating food and beverages; gas, electric and solid fuel grills and barbecues for cooking; parts and fittings for all the aforementioned goods; cooking apparatus, namely, barbecues, gas barbecues, barbecue grills and gas grills for cooking, parts, and accessories for the aforementioned goods, namely, rotisseries, trolleys specially adapted for barbecues, travel bags specially adapted for barbecues, (collectively being referred to as the "Products") upon which the Trade Marks are used and for which they are registered (the "Goodwill").
- B. By the same agreement dated 13 November 2015 the Assignor assigned to the Assignee all right, title and interest to the design patents referred to in Schedule 2 (collectively referred to as the "Designs").
- C. The Assignor desires to confirm that it has conveyed, transferred, assigned and delivered to the Assignee and to confirm that it has done so as of 13 November 2015, all of its right, title and interest in and to the Trade Marks and Trade Dress in the Trade Marks along with the Goodwill and in and to the Designs.

THIS DEED WITNESSES that, pursuant to the arrangement between the Assignor and the Assignee and the mutual promises contained in this Deed, the parties agree:

## 1 Assignment

### 1.1 Trade Marks, Goodwill and Designs

The Assignor hereby confirms that it has conveyed, transferred, assigned and delivered to the Assignee and confirms that it has done so as of 13 November 2015, all of its right, title and interest in and to the Trade Marks and Trade Dress in the Trade Marks along with the Goodwill, and in and to the Designs, free from all encumbrances, including all income, royalties and damages that become due or payable to the Assignor with respect to the Trade Marks and or the Designs,

including damages and payments for past and future infringements and misappropriation of the Trade Marks and or the Designs.

## 1.2 Third Parties

To the extent (if any) that the Assignor has, had or will have the right to take any action against any third parties for infringement of the Trade Marks and or the Designs (including infringement of any copyright or common law rights), the Assignor confirms the assignment and transfer to the Assignee of all such rights whether or not such infringement took place prior to the date of this Deed.

## 2 Recordal of Assignment

The Assignor shall execute all such documents and do all such things as may be necessary, proper, desirable or reasonably requested by the Assignee to enable the Assignee (and its agents/representatives) to record the Assignee as the owner or the applicant (as the case may be) in respect of the Designs, and as the owner of the Trade Marks, or of any other intellectual property rights subsisting in or relating to the Designs and/or the Trade Marks.
