DOES HEREBY CERTIFY:

FIRST: The Corporation owns 100% of the capital stock of Omaha World-Herald Company, a Delaware corporation (the "Subsidiary"), incorporated on December 19, 1962 pursuant to the provisions of the General Corporation Law of the State of Delaware, and that the Corporation, by resolutions of its Board of Directors duly adopted by written consent in lieu of a meeting on December 4, 2015, determined to merge into itself the Subsidiary, which resolutions are in the following words to wit:

WHEREAS, the Corporation lawfully owns 100% of the outstanding capital stock of the Subsidiary; and

WHEREAS, the Corporation desires to merge the Subsidiary into itself and to be possessed of all the estate, property, rights, privileges, and franchises of the Subsidiary.

NOW, THEREFORE, BE IT:

RESOLVED, that the Corporation is hereby authorized to merge the Subsidiary into itself and assume all of its liabilities and obligations.

RESOLVED FURTHER, that the officers of the Corporation are hereby authorized and directed to make and execute a Certificate of Ownership and to file the same in the office of the Delaware Secretary of State.

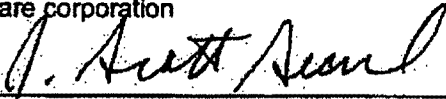
RESOLVED FURTHER, that the officers of the Corporation are hereby authorized and directed to do all acts and things whatsoever, whether within or outside the State of Delaware, which may be in any way necessary or proper to effect said merger.

RESOLVED FURTHER, that the merger shall become effective at 12:03 a.m. on December 28, 2015.

SECOND: That anything herein or elsewhere to the contrary notwithstanding, this merger may be amended or terminated and abandoned by the Board of Directors of the Corporation at any time prior to the time that this merger filed with the Secretary of State becomes effective.
