**PARTIAL RELEASE OF TRADEMARK COLLATERAL**

THIS PARTIAL RELEASE OF TRADEMARKS COLLATERAL (this "Release"), dated as of February 29, 2016, is made by **ALLIANCE BUSINESS LENDING, LLC**, a Kentucky limited liability company ("Lender"), and is as follows:

WHEREAS, **INTERSTAR NORTH AMERICA, INC.**, a Kentucky corporation ("Borrower"), and Lender are parties to that certain Trademark Collateral Rider dated as of August 30, 2013 (the "Collateral Rider"), which was recorded with The United States Patent and Trademark Office on August 30, 2013, in its records at Reel 5101, Frame 0633. Capitalized terms used but not defined herein will have the meaning given to them in the Collateral Rider;

WHEREAS, the Collateral Rider granted to Lender a security interest in all of the Borrower's right, title and interest in and to the Trademarks described on Schedule I attached hereto (collectively, the "Designated Trademarks"); and

WHEREAS, Lender desires to release its rights and security interests solely in the Designated Trademarks.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Lender hereby releases and terminates its lien solely on the Designated Trademarks; *provided, that*, Borrower hereby acknowledges and agrees that this is a partial release of collateral and that Lender will continue to have its lien on and security interest in all of the other Trademark Collateral and all of the other Collateral (as defined in the Security Agreement) other than as it respects the Designated Trademarks. For the avoidance of any doubt, Borrower hereby acknowledges and agrees that, notwithstanding anything to the contrary herein, except with respect to the Designated Trademarks specifically identified on Schedule I, none of this Release or any of the terms contained herein shall in any manner adversely affect, replace, impair, or extinguish the creation, attachment, perfection or priority of any liens in favor of Lender on any Loan Collateral granted pursuant to any Loan Document, which such liens are hereby ratified and reaffirmed by Borrower to Lender in all respects.
