## TERMINATION AND RELEASE OF TRADEMARK SECURITY INTEREST

This TERMINATION AND RELEASE OF TRADEMARK SECURITY INTEREST ("Termination and Release") dated as of March 11, 2016, is made from CIT BANK, N.A. (formerly known as OneWest Bank N.A., which was formerly known as OneWest Bank, FSB), as administrative agent for the Lenders (in such capacity, the "Agent") to ELECTRO-OPTICAL INDUSTRIES, LLC, a California limited liability company (the "Grantor"). Capitalized terms used in this Termination and Release and not otherwise defined herein have the meanings specified in the Credit Agreement (as defined in the Security Agreement), the Security Agreement (defined below) or the Grant of Trademark Security Interest (defined below), as applicable.

### WITNESSETH:

WHEREAS, pursuant to that certain Security Agreement dated as of April 22, 2013, (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the "Security Agreement"), by and among the Grantor, the Agent, and the other Grantors party thereto, the Grantor executed that certain Grant of Trademark Security Interest, dated as of April 22, 2013 (as amended, restated, supplemented or otherwise modified from time to time, the "Grant of Trademark Security Interest"), which was recorded in the United States Patent and Trademark Office at Trademark Reel 5011 Frame 0886, pursuant to which the Grantor granted a security interest to the Agent, for the benefit of the Lenders, in the Trademark Collateral, including certain trademarks and/or trademark applications listed on Schedule A hereto and made a part hereof.

WHEREAS, the Agent now desires to terminate and release its security interest in the Trademark Collateral and reassign any and all rights, title, and interest in the same to Grantor;

NOW, THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:


1. Agent hereby releases its security interest in all of Grantor's right, title and interest in and to the Trademark Collateral, including those trademarks set forth on Schedule A.
