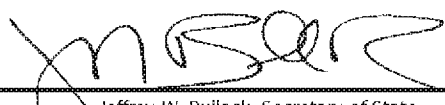

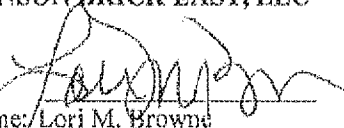
FIRST: The name of the limited liability company is Hanson Brick East, LLC.
