RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS dated March 14, 2016 by BMO HARRIS BANK N.A., a national banking association, with its mailing address at 115 South LaSalle Street, 4W, Chicago, IL 60603, acting as administrative agent hereunder for the Lenders as defined in the Agreement referred to below (in such capacity, the “Agent”);

WITNESSETH:

WHEREAS, Dimont & Associates, Inc., a California corporation (“Debtor”), with its mailing address at 100 Federal Street, 31st Floor, Boston, MA 02110, and Agent are parties to a certain Trademark Security Agreement dated May 21, 2013 between Debtor and Agent which was recorded in the United States Patent and Trademark Office on August 14, 2013 at Reel 005091, Frame 0126 (the “Agreement”), pursuant to which Debtor granted to Agent, a security interest in, among other things, the trademarks, trademark registration, and trademark applications listed on Schedule A attached hereto and certain other property (collectively, the “Trademark Property”); and

WHEREAS, Debtor has requested that Agent release its security interests in the Trademark Property;

NOW, THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:

Agent hereby releases its security interests in, and hereby reassigns, grants and conveys to Debtor, without any representation, warranty, recourse or undertaking by Agent, all of its right, title and interest, if any, in and to each trademark, trademark registration, and trademark application listed on Schedule A hereto, including:

(a) all of its Trademarks and Trademark Licenses to which the Debtor is a party including those referred to on Schedule A hereto;

(b) all goodwill of the business connected with the use of, and symbolized by, each Trademark; and


(c) all products and proceeds of the foregoing, including without limitation any claim by Debtor against third parties for past, present or future (i) infringement or dilution of any Trademark or Trademark License under any Trademark License if Debtor has the right to make such a claim under such Trademark License or (ii) injury to the goodwill associated with any Trademark or any Trademark License if Debtor has the right to make such a claim under such Trademark License.

All capitalized terms used above without definition shall have the same meanings herein as such terms have in the Agreement.
