Assignor agrees to execute any further papers as may be necessary and proper to vest full title in and to the Domain Names and the Marks and other corresponding rights in the Assignee, its successors, assigns and legal representatives.

Assignor hereby consents to the recordation of this assignment in the territories listed in Schedule "A" and any other territories as appropriate.
