## TERMINATION AND RELEASE OF TRADEMARK SECURITY AGREEMENT

**TERMINATION AND RELEASE OF TRADEMARK SECURITY AGREEMENT** ("Release"), dated as of February 26, 2016, by **WEBSTER BANK, N.A.**, as successor administrative agent (the "Administrative Agent"), in favor of **VERACTION, LLC** (formerly known as Accuship.com, LLC), a Georgia limited liability company (the "Company").

**WHEREAS**, pursuant to the terms of that certain Trademark Security Agreement, by the Company in favor of the Administrative Agent, dated as of March 28, 2014 (the "Trademark Security Agreement"), the Company granted to the Administrative Agent a continuing security interest in the Trademark Collateral (as defined in the Trademark Security Agreement) including, but not limited to, those registered trademarks of the Company listed on Schedule A attached hereto and made a part hereof (collectively, the "Trademarks"), to secure the prompt performance of the Secured Obligations (as defined in the Credit Agreement (defined in the Trademark Security Agreement));

**WHEREAS**, the Administrative Agent wishes to terminate and release its security interest in and to all of the right, title and interest of the Company in and to the Trademark Collateral, including the Trademarks identified on Schedule A attached hereto; and


**WHEREAS**, the Trademark Security Agreement was recorded on March 31, 2014 with the United States Patent and Trademark Office in Reel: 5247; Frame: 0739.

**NOW THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Administrative Agent hereby terminates, releases and discharges fully its security interest in and to all of the right, title and interest of the Company in and to the Trademark Collateral, including the Trademarks identified on Schedule A attached hereto, and reassigns and transfers to the Company all right, title and interest that the Administrative Agent may have in the Trademark Collateral, and terminates the Trademark Security Agreement. The Administrative Agent hereby authorizes the Company, or the Company's authorized representative, to record this Release with the United States Patent and Trademark Office.
