TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARK RIGHTS dated as of March 14, 2016 (this "Termination and Release"), from Royal Bank of Canada, in its capacity as Administrative Agent (the "Agent"), to the entities listed on Schedule B hereto (the "Grantors").

WITNESSETH:

WHEREAS, pursuant to (a) the Guarantee and Collateral Agreement dated as of July 17, 2012, among PAE Holding Corporation, the Grantors party thereto and the Agent (together with all amendments and modifications, if any, from time to time made thereto, the "Security Agreement") and (b) the Grant of Security Interest in Trademark Rights, dated as of July 17, 2012, between the Agent and the Grantors (the "Trademark Security Agreement"), the Grantors granted to the Agent for the ratable benefit of the Secured Parties, a security interest (the "Security Interest") in certain collateral, including the Trademark Collateral (as hereinafter defined);

WHEREAS, the Trademark Security Agreement was recorded in the United States Patent and Trademark Office on July 20, 2012, at Reel 4826 and Frame 0764; and

WHEREAS, the Agent now desires to terminate and release the entirety of the Security Interest in the Trademark Collateral.

NOW, THEREFORE, for good and valuable consideration, including the satisfaction of all indebtedness and other obligations, secured by the Trademark Collateral, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Termination and Release, the Agent hereby states as follows:

1. Definitions. The term "Trademark Collateral," as used herein, shall mean all of each Grantor's right, title and interest of every kind and nature in, to and under the Trademarks listed on Schedule A hereto, including the right to receive all Proceeds therefrom. Unless otherwise defined herein or the context otherwise requires, terms used in this Termination and Release, including the preamble and the recitals, have the meanings provided or provided by reference in the Security Agreement.

2. Release of Security Interest. The Agent hereby terminates, releases and discharges the Security Interest in the Trademark Collateral, and any right, title or interest of the Agent in the Trademark Collateral shall hereby cease and become void.
