Release of Grant of Security Interest in Trademark Rights

This Release of Grant of Security Interest in Trademark Rights is executed as of March 7, 2016 (this "Release"), by Deutsche Bank AG, London Branch, as Security Agent for the Secured Parties (the "Security Agent"), for the benefit of Money2020, LLC (the "Grantor").

WITNESSETH:

Whereas, pursuant to a Grant of Security Interest in Trademark Rights dated as of May 20, 2015 (the "Agreement"; any capitalized term used but not otherwise defined herein shall have the meaning assigned to such term in the Agreement) between the Grantor and the Security Agent, which Agreement was recorded in the US Patent and Trademark Office (the "Office") on May 21, 2015, at Reel 5521, Frame 0105, the Grantor has granted a security interest in its right, title and interest in and to the trademarks (the "Trademarks") to the Security Agent, for the benefit of the Secured Parties.

Whereas, the Security Agent (acting on behalf of the Secured Parties) has agreed to release the security interests created under the Agreement with respect to the Trademarks, which are listed in Schedule 1, on the terms and conditions set forth in that certain Global Deed of Release, dated February 12, 2016 between, amongst others, the Security Agent and Ascential Holdings Limited (formerly known as Eden Acquisition 5 Limited) as parent.

Now, therefore, in consideration of the foregoing and for other valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Security Agent (acting on behalf of the Secured Parties) hereby releases the security interests over the Trademarks created by the Agreement as of the date first written above.


The Security Agent shall, at the Grantor's expense, take all further actions, and provide to Grantor, its successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), requested by Grantor so long as such action, cooperation or assistance is necessary to more fully and effectively effectuate the purposes of this Release.

This Release shall be governed by and construed in accordance with the laws of the State of New York (including, without limitation, Section 5-1401 of the General Obligations Law of the State of New York), without regard to conflict of laws principles that would require application of another law. This Release will be binding upon and inure to the benefit of each party and its successors and assigns.

The Security Agent hereby authorizes and requests that the Commissioner of Patents and Trademarks record this Release.


