Assignor authorizes the Commissioner of Trademarks of the United States and other empowered officials of the United States Patent and Trademark Office and in any applicable jurisdictions outside of the United States to record the transfer of the Trademarks set forth on Exhibit A to Assignee of Assignor's entire right, title and interest therein. Assignor covenants, agrees, and undertakes to execute, whenever requested by Assignee, any documents reasonably necessary to effect this assignment, to confirm Assignee's ownership of the Trademarks, and/or to maintain the Trademarks.


