FIFTH: The executed Plan of Merger is on file at an office of the Surviving Company, located at Two Greenwich Office Park, Greenwich, CT 06831.

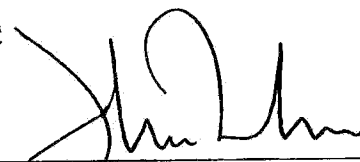
