## TRADEMARK ASSIGNMENT

THIS TRADEMARK ASSIGNMENT (this "Assignment") is entered into as of October 31, 2006 by AXS-One Inc., a Delaware corporation ("Assignor"), in favor of Computron Software, LLC, a Delaware limited liability company ("Assignee"). This Assignment is further documentation of the transfers, conveyances and assignments contemplated by the Purchase Agreement and is subject to all of the terms, provisions and conditions thereof. Nothing in this Assignment shall constitute a waiver of, expansion of or limitation upon Assignor's or Assignee's rights, remedies, obligations, representations, warranties and covenants under the Purchase Agreement, and in the case of any conflict between the terms of the Purchase Agreement and this Assignment, the Purchase Agreement shall govern.

This Assignment shall be binding upon and shall inure solely to the benefit of Assignor, Assignee and their respective successors and assigns.

This Assignment shall be governed by and construed in accordance with the domestic laws of the State of New York without giving effect to any choice or conflict of law provision or rule (whether of the New York or any other jurisdiction) that would cause the application of the laws of any jurisdiction other than the New York.

This Assignment may be delivered by electronic mail or facsimile transmission.
