**Russell R. Mantione** does hereby swear and attest that:

1. I am the **Chief Financial Officer** of Printers' Service, Inc., and I make this declaration from my own knowledge or from a perusal of the records of Printers' Service, Inc., to which I have access appropriate to my position.

2. I am making this declaration to explain the facts relating to the assignment from Blankets, Inc. to Printers' Service, Inc. of the mark PRISCOLITH (the "Trademark"), which is the subject of United States Registration No. 1,650,112 dated July 9, 1991, as set forth in the Confirmatory Assignment dated July 20, 2011 (the "Assignment Document"), which is recorded with the United States Patent and Trademark Office at Reel/Frame 4591/0608.

3. Before its dissolution, the assignor, Blankets, Inc., formerly a Delaware corporation with offices at 26 Blanchard Street, Newark, New Jersey 07105, was a related company of the assignee, Printers' Service, Inc.


4. In the Assignment Document, Printers' Service, Inc. was inadvertently identified as a Delaware corporation.

5. Printers' Service, Inc. was never a Delaware corporation. Rather, since the time of the execution of the Assignment Document and until now, the correct entity type of Printers' Service, Inc. was and continues to be a New Jersey corporation. A copy of the a certificate from the Department of State of the State of New Jersey certifying that Printers' Service, Inc. has been a New Jersey corporation since January 15, 1987 is attached hereto and incorporated herein.

It is therefore submitted that all records of the United States Patent and Trademark Office in connection with Registration No. 1,650,112 for the Trademark should be amended to correct the entity type of the Registrant from a Delaware corporation to a New Jersey corporation, effective as of the execution of the Assignment Document on July 20, 2011.

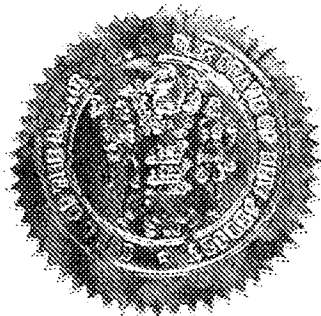
