ASSIGNMENT OF TRADEMARKS

WHEREAS, Assignor and Assignee wish to further confirm and document said assignment of rights in the Marks;

THEREFORE, for good and valuable consideration, the receipt and adequacy of which is hereby acknowledged (which includes Assignor’s Marks and Assignee’s willingness to carry on Assignor’s business and manage and pay for Assignor’s dissolution), Assignor assigns to Assignee, effective on the later of the two dates on which the Parties to this Assignment sign this document (the “Effective Date”), all right, title and interest in and to the Marks, together with the goodwill of the business symbolized by the Marks and the registrations and applications thereof and all of Assignor’s business, including all portions of its business to which the Marks pertain.

This Assignment may be executed in counterparts or duplicate originals, both of which shall be regarded as one and the same instrument, and which shall be the official and governing version in the interpretation of this Assignment. This Assignment may be executed by facsimile or electronic copies of signatures and such signatures shall be deemed to bind each Party as if they were original signatures.
