**RELEASE OF SECURITY INTEREST
IN TRADEMARK COLLATERAL**

This RELEASE, dated as of February 25, 2016 (this "Release"), is made by Antares Capital LP (successor by assignment to General Electric Capital Corporation), as Administrative Agent ("Agent"), in favor of Three Eagles Communications, Inc., a Delaware corporation (the "Grantor") as follows:

WITNESSETH

The Agent agrees to provide Grantor with any information and additional authorization and documentation necessary to effect the release of the Agent's security interest in the Trademark Collateral (without recourse, representation or warranty and at the sole cost and expense of the Grantor).
