Pursuant to Title 8, Section 264(c) of the Delaware General Corporation Law (the "**DGCL**"), GTAT Corporation (the "**Corporation**"), a Delaware corporation, does hereby certify to the following information relating to the merger (the "**Merger**") of GT Crystal Systems, LLC, a Delaware limited liability company (the "**Subsidiary**"), and together with the Corporation, the "**Constituent Companies**"), with and into the Corporation, with the Corporation remaining as the surviving corporation:

1. The Corporation owns all of the outstanding membership interests of the Subsidiary.
