ARTICLES OF MERGER

Pursuant to Sec. 4A-703 of the Maryland Limited Liability Company Act, the undersigned limited liability company submits the following for filing:

1. Advanced Education Systems, LLC, a Maryland limited liability company, agrees to merge into OnCourse Learning Corporation, a Delaware corporation, the surviving entity (collectively the "the Constituent Entities").
2. Advanced Education Systems, LLC is a limited liability company organized under the laws of the State of Maryland.
3. OnCourse Learning Corporation was incorporated under general law on February 20, 2007 under the name of Trainco Holdings Corp. and a Certificate of Amendment was filed on January 27, 2009 to change the name to OnCourse Learning Corporation.
4. The principal address of Advanced Education Systems, LLC is 11350 McCormick Road, Suite 1000, Baltimore County, Hunt Valley, Maryland 21013.
5. The principal address of OnCourse Learning Corporation is N19 W24075 Riverwood Drive, Suite 200, Waukesha, Wisconsin 53188. ✓
6. OnCourse Learning Corporation does not have a principal office located in the State of Maryland.
7. The name and address of the registered agent of OnCourse Learning Corporation is The Corporation Trust Company, 2109 Orange Street, Wilmington, Delaware 19801. ✓
8. Neither party to this merger own an interest in land in the State of Maryland. ✓
9. The terms and conditions of the merger were advised, authorized, and approved by Advanced Education Systems, LLC and OnCourse Learning Corporation in the manner and by the vote required by its Articles of Organization and Certificate of Formation, respectively, and the laws of the state where it was organized and incorporated. The manner of approval was by unanimous written consent of the members of Advanced Education Systems, LLC and by unanimous written consent of the shareholders and Board of Directors of OnCourse Learning Corporation.
10. The total number of shares which OnCourse Learning Corporation has the authority to issue is 30,000 shares of common stock with a par value of \$.01 per share.
11. One hundred percent (100%) of the membership interests of Advanced Education Systems, LLC is owned by OnCourse Learning Corporation.
12. The effective date and time of the Merger shall be December 31, 2015 at 11:59 p.m. EST.

13. The laws of the State of Delaware shall govern OnCourse Learning Corporation as the surviving entity. The Certificate of Incorporation of OnCourse Learning Corporation shall, at the effective time of the Merger, remain in effect, as the Certificate of Incorporation of OnCourse Learning Corporation as the surviving entity, until the same shall be further amended or altered in accordance with the provisions thereof.
14. The Bylaws of OnCourse Learning Corporation at the effective time of the Merger shall be the Bylaws of the OnCourse Learning Corporation as the surviving entity until altered or amended in accordance with the provisions thereof.
15. The Directors and Officers of OnCourse Learning Corporation at the effective time of the Merger shall be and remain the Directors and Officers of the OnCourse Learning Corporation as the surviving entity, and they shall hold their office until their respective successors are duly elected and qualified.
16. The mode of carrying into effect the Merger is as follows:
- Advanced Education Systems, LLC. Each outstanding unit of membership of Advanced Education Systems, LLC shall be extinguished.
 - Surrender of Certificates. After the effective time of the Merger, each holder of an outstanding certificate or certificates representing membership units of Advanced Education Systems, LLC shall surrender such certificates to the OnCourse Learning Corporation for cancellation.
