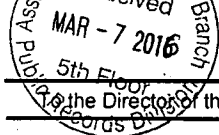

**GRANT OF SECURITY INTEREST
TRADEMARKS**

THIS GRANT OF SECURITY INTEREST, dated as of December 2, 2015 is executed by Passport Food Safety Solutions, Inc., a Utah corporation ("Borrower"), in favor of LRF Development III, LLC, a Utah limited liability company ("Secured Party").

C. Borrower desires to grant to Secured Party a security interest in all right, title and interest of Borrower in and to the Trademarks, together with the goodwill of the business symbolized by the Trademarks and the applications and registrations thereof, and all proceeds thereof, including any and all causes of action that may exist by reason of infringement thereof (the "Collateral"), to secure all debts secured by the Security Agreement (the "Obligations").

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, Borrower does hereby grant to Secured Party a security interest in the Collateral to secure the prompt payment, performance and observance of the Obligations.


