**FIRST:** The name of the surviving corporation is Passport Health Communications, Inc. (the "Surviving Corporation") and the name of the corporation being merged into this surviving corporation is Medical Present Value, Inc., a Delaware corporation (the "Merging Corporation").

**CERTIFICATE OF AMENDMENT TO  
CERTIFICATE OF INCORPORATION**

Passport Health Communications, Inc., a corporation organized and existing under and by virtue of the General Corporation Law of the State of Delaware, hereby certifies as follows:

The name of this corporation is Passport Health Communications, Inc. and the amended and restated Certificate of Incorporation of the corporation was filed with the Secretary of State of the State of Delaware on May 5, 2009.

The Amendment to the Certificate of Incorporation as set forth below has been duly adopted in accordance with the provisions of Sections 242 and 228 of the General Corporation Law of the State of Delaware and the board of directors and the sole stockholders have given written consent to said amendment in accordance with the provisions of Sections 141 and 228 of the General Corporation Law of the State of Delaware.

The text of the Certificate of Incorporation is hereby amended by deleting Article I in its entirety and replacing it with the following:

**FIRST**

The name of the Corporation is Experian Health, Inc.

The remaining portions of the Certificate of Incorporation are unchanged.
