Reference is hereby made to that certain Intellectual Property Security Agreement, dated as of October 15, 2014 (the "Agreement"), executed by and between Clarus Commerce LLC (f/k/a Clarus Marketing Group, LLC), a Connecticut liability company (the "Grantor"), and East West Bank, a California banking corporation (the "Secured Party"), which was recorded in the United States Patent and Trademark Office ("USPTO") on October 22, 2014 at Reel 5385, Frame 0736, pursuant to which the Grantor assigned and granted to the Secured Party a continuing security interest in and to all of the Grantor's right, title and interest in and to certain Intellectual Property Collateral (as defined in the Agreement), including those trademarks and trademark applications specifically listed on Exhibit A attached hereto and the goodwill associated therewith (the "Trademark Collateral");

WHEREAS, the Secured Party wishes to terminate, cancel, release, relinquish and discharge its continuing security interest in the Intellectual Property Collateral, and retransfer and reassign to the Grantor, without representation or warranty, all of the Grantor's right, title and interest in and to the Trademark Collateral.

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, the Secured Party hereby terminates, cancels, releases, relinquishes and discharges its continuing security interest in the Intellectual Property Collateral, and retransfers and reassigns to the Grantor, without representation or warranty, all of the Secured Party's right, title and interest in and to the Trademarks and reassigns to the Grantor any and all such right, title and interest in and to the Trademark Collateral.
