BETWEEN:

- (1) **EUSA Pharma (Europe) Limited**, a company incorporated in England (registered number: 04555273), whose registered office is at Wing B, Building 5700, Spires House, John Smith Drive, Oxford Business Park, South Oxford, OX4 2RW, England; and
 - (2) **Jazz Pharmaceuticals, Inc.**, a company incorporated in Delaware, whose office is at 3180 Porter Drive, Palo Alto, CA 94304, U.S.A.;
- (each an "**Assignor**", together the "**Assignors**"); and
- (3) **Essex Bidco Limited**, a company incorporated in England (registered number 9329429), whose office is at Berkeley Square House, Berkeley Square, London W1J6BR (the "**Assignee**").

RECITALS:

- (A) Pursuant to a sale and purchase agreement dated 30 December 2014, as amended and restated on or around the date of this Assignment, the Assignee is acquiring certain assets of Jazz Pharmaceuticals PLC, a company incorporated in Ireland (registered number 399192) whose registered office is at Fourth Floor, Connaught House, One Burlington Road, Dublin 4, Ireland (such agreement, the "**APA**").
- (B) The Assignors are the registered proprietors of the Trade Marks set out in Schedule 1 to this Assignment which are to be assigned pursuant to the APA.
- (C) The Assignors have agreed to assign to the Assignee the Trade Marks together with the goodwill associated with them on the terms and subject to the conditions of this Assignment.

IT IS AGREED:

1. **INTERPRETATION**

In this Assignment:

- 1.1 except where the context otherwise requires the following words and expressions shall have the following meanings:

"third party" means a person other than a party to this Assignment;

"Trade Marks" means the registered trade marks and trade mark applications, short particulars of which are set out in Schedule 1 to this Assignment, and each and any of them;

- 1.2 the singular includes the plural and vice versa.

2. **ASSIGNMENT**

Pursuant to the APA, each Assignor hereby assigns with full title guarantee to the Assignee absolutely:

- (a) all property, rights, title and interest in the Trade Marks set out opposite its name in Schedule 1, including all common law rights connected therewith; together with
- (b) the goodwill associated with the Trade Marks.

3. **FURTHER ASSURANCE**

- 3.1 Subject to clause 3.2, each Assignor shall, at its own expense and on the reasonable request of the Assignee, execute all documents and do all acts and things as the Assignee reasonably requires to vest absolute legal and beneficial ownership of the Trade Marks in the Assignee or to perfect the Assignee's title thereto, and to enable the Assignee to record the transfer of the Trade Marks with any relevant trade mark registry (the "**Trade Mark Recordal**").
- 3.2 The Assignee shall pay all costs of the Trade Mark Recordal including any fees payable to the trade mark registries to record the transfer of the Trade Marks.

4. **GENERAL**

- 4.1 **Entire agreement:** This Assignment together with the APA sets out the entire agreement and understanding between the parties, and supersedes all proposals and prior agreements, arrangements and understandings between the parties, relating to its subject matter.
- 4.2 **Acknowledgment:** Each party acknowledges that in entering into this Assignment it does not rely on any representation, warranty, collateral contract or other assurance of any person (whether party to this Assignment or not) that is not set out in this Assignment or the APA. Each party waives all rights and remedies which, but for this clause, might otherwise be available to it in respect of any such representation, warranty, collateral contract or other assurance. Nothing in this Assignment shall, however, limit or exclude any liability for fraud.
- 4.3 **Variation:** No variation of this Assignment shall be effective unless it is in writing and is signed by or on behalf of each of the parties.
- 4.4 **Waiver:** Delay in exercising, or failure to exercise, any right or remedy in connection with this Assignment shall not operate as a waiver of that right or remedy. The waiver of a right to require compliance with any provision of this Assignment in any instance shall not operate as a waiver of any further exercise or enforcement of that right and the waiver of any breach shall not operate as a waiver of any subsequent breach. No waiver in connection with this Assignment shall, in any event, be effective unless it is in writing.
- 4.5 **Severability:** The parties intend each provision of this Assignment to be severable and distinct from the others. If a provision of this Assignment is held to be illegal, invalid or unenforceable, in whole or in part, the parties intend that the legality, validity and enforceability of the remainder of this Assignment shall not be affected.
- 4.6 **Counterparts:** This Assignment may be entered into in any number of counterparts and by the parties on separate counterparts, all of which taken together shall constitute one and the same instrument.
- 4.7 **Third Party Rights:** No third party may enforce any term of this Assignment by virtue of the Contracts (Rights of Third Parties) Act 1999.

- 4.8 **Law:** This Assignment and the jurisdiction clause contained in it shall be governed by and construed in accordance with English law.
- 4.9 **Jurisdiction:** The parties agree that the courts of England shall have exclusive jurisdiction to settle any claim or dispute arising out of or in connection with this Assignment or its subject matter or formation (including non-contractual disputes or claims).


