

DOES HEREBY CERTIFY as follows:

FIRST: The name of the Corporation is EUSA Pharma (USA), Inc.

SECOND: The date on which the Certificate of Incorporation of the Corporation was originally filed with the Secretary of State of the State of Delaware is March 3, 1980.
