**TERMINATION AND RELEASE OF
SECURITY INTEREST IN TRADEMARKS**

This Termination and Release of Security Interest in Trademarks ("Trademark Release") is made as of March 23, 2016, by BARCLAYS BANK PLC, a United Kingdom private limited company (the "Agent").

WITNESSETH:

WHEREAS NORTHGATEARINSO UK LIMITED, a United Kingdom private limited company, located at Peoplebuilding 2, Peoplebuilding Estate Maylands, Avenue Hemel, Hempstead, Hertfordshire HP24NW, United Kingdom (the "Obligor"), entered into a certain Grant of Security Interest in Trademark Rights dated April 19, 2011 (the "Grant") with the Agent, notice of which was recorded on April 26, 2011 at the United States Patent and Trademark Office at Reel 4528, Frame 0756.

WHEREAS, Obligor granted the Agent, under the terms of the Grant, a continuing second priority security interest (the "Security Interest") in favor of the Agent and the Subordinated Finance Parties (as such term is used in the Grant), in and to certain of Obligor's Trademarks (as such term is used in the Grant), including the Trademarks listed in Schedule A, all of the goodwill of the business connected with the use of, and symbolized by the Trademarks, as well as all Proceeds (as such term is used in the Grant) and claims based on past, present, or future infringement.

WHEREAS, the Agent has agreed to terminate and release its security interest in all such Trademarks as herein provided.


NOW, THEREFORE, in consideration of the foregoing and intending to be legally bound, the Agent, for itself and on behalf of the Subordinated Finance Parties in association with the Security Interest, hereby releases, terminates and discharges any and all of its interest in the intellectual property of the Obligor, including the Trademarks, and all of the goodwill of the business connected with the use of, and symbolized by the Trademarks, and assigns, transfers and conveys to Obligor any interest in such intellectual property, including the Security Interest.
