## ASSIGNMENT

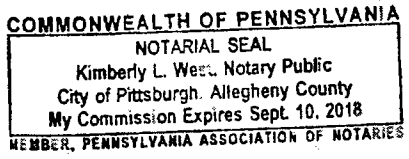
