TRADEMARK SECURITY AGREEMENT dated as of March 23, 2016 (this “*Agreement*”), among EMINENT, INC. (“*Eminent*”), ALLIANCE APPAREL GROUP, INC. (together with Eminent, the “*Grantors*”) and BANK OF AMERICA, N.A., as collateral agent (in such capacity, the “*Collateral Agent*”).

Reference is made to (a) the Security Agreement dated as of March 23, 2016 (as amended, supplemented or otherwise modified from time to time, the “*Security Agreement*”), among the Borrowers, the Parents, the Subsidiaries of the Parents party thereto from time to time as Guarantors, the Lenders and the Collateral Agent and (b) the Credit Agreement dated as of March 23, 2016 (as amended, supplemented or otherwise modified from time to time, the “*Credit Agreement*”), among Borrowers, the Parents, the Subsidiaries of the Parents party thereto from time to time as Guarantors, the Lenders and the Collateral Agent. The Lenders have agreed to extend credit to the Borrower subject to the terms and conditions set forth in the Credit Agreement. The obligations of the Lenders to extend such credit are conditioned upon, among other things, the execution and delivery of this Agreement. The Grantors are affiliates of the Borrowers, will derive substantial benefits from the extension of credit to the Borrowers pursuant to the Credit Agreement and are willing to execute and deliver this Agreement in order to induce the Lenders to extend such credit. Accordingly, the parties hereto agree as follows:

SECTION 1. Terms. Capitalized terms used herein and not otherwise defined shall have the meanings assigned to such terms in the Security Agreement or the Credit Agreement, as applicable. The rules of construction specified in Article I of the Credit Agreement also apply to this Agreement.

SECTION 2. Grant of Security Interest. As security for the prompt and complete payment and performance in full of the Secured Obligations, each Grantor, pursuant to the Security Agreement, did and hereby does grant to the Collateral Agent and its successors and assigns, for the benefit of the Lenders, a security interest in all right, title or interest in or to any and all of the following assets and properties now owned or at any time hereafter acquired by such Grantor or in which such Grantor now has or at any time in the future may acquire any right, title or interest (collectively, the “*Trademark Collateral*”): (a) all common law trademarks, trademark registrations and trademark applications, common law service marks, service mark registrations and service mark applications, and trade names, corporate names, trade dress and logos, including those set forth on Schedule I hereto, and the goodwill of the business symbolized by the foregoing; (b) all extensions and renewals of the foregoing; (c) all income, royalties, damages and payments now or hereafter due or payable with respect thereto, including, without limitation, damages, claims and payments for past and future infringements thereof; (d) all rights to sue for past, present and future infringements of the foregoing; and (e) all rights corresponding to any of the foregoing throughout the world.

SECTION 3. Certain Limited Exclusions. Notwithstanding anything herein to the contrary, in no event shall the Trademark Collateral include or the security interest granted under Section 2 hereof attach to any application to register a Trademark in the U.S. Patent and Trademark Office (the “PTO”) based upon Grantor’s “intent to use” such Trademark (but only if the grant of security interest in such “intent to use” Trademark applications violates 15 U.S.C. §1060(a)) unless and until a “Statement of Use” or “Amendment to Allege Use” is filed in the PTO with respect thereto.

SECTION 4. Security Agreement. The security interests granted to the Collateral Agent herein are granted in conjunction, and not in limitation of, the security interests granted to the Collateral Agent pursuant to the Security Agreement. Each Grantor hereby acknowledges and affirms that the rights and remedies of the Collateral Agent with respect to the Trademark Collateral are more fully set forth in the Security Agreement, the terms and provisions of which are hereby incorporated herein by reference as if fully set forth herein. In the event of any conflict between the terms of this Agreement and the Security Agreement, the terms of the Security Agreement shall govern.


SECTION 5. Choice of Law. THIS AGREEMENT SHALL BE CONSTRUED IN ACCORDANCE WITH AND GOVERNED BY THE LAWS OF THE STATE OF NEW YORK.

SECTION 6. Counterpart. This Agreement may be executed in one or more counterparts and by different parties hereto in separate counterparts, each of which when so executed and delivered shall be deemed an original, but all such counterparts together shall constitute but one and the same instrument.






