EXHIBIT A

TERMINATION OF TRADEMARK SECURITY INTEREST

This is a Termination of Trademark Security Interest, dated as of March ²⁴, 2016, executed by or on behalf of Bank of the West ("Secured Party"), releasing all security interests of Secured Party in the Trademarks (defined below) owned by Eminent, Inc., a Delaware corporation ("Eminent"), Forward by Elyse Walker, LLC, a California limited liability company ("Forward"), and Alliance Apparel Group, Inc., a Delaware corporation ("Alliance," and together with Forward and Eminent, "Debtor").

RECITALS

WHEREAS, Debtor desires termination of Secured Party's security interest in the Trademarks;
and

WHEREAS, Secured Party is willing to terminate their security interest in the Trademarks;

NOW, THEREFORE, in consideration of the foregoing, the receipt and sufficiency of which is hereby acknowledged, Secured Party agrees as follows:

AGREEMENT

1. Termination of Security Interest. Secured Party hereby terminates, releases, relinquishes, and discharges all of Secured Party's security interest in the Trademarks, and reassigns to each Debtor all right, title and interest it may have in the Trademarks.

2. Revocation of Power of Attorney. Any powers of attorney granted by Debtor to Secured Party in connection with the grant of security interest in the Trademarks is hereby revoked.
