RELEASE OF SECURITY INTEREST
IN TRADEMARKS

J. The Lender agrees, at the Grantor's expense, to cooperate with the Grantor and to provide the Grantor with the information and additional authorization reasonably required or desirable to effect the release of the Lender's security interest in the Released Mark.

Grantor, or its designee, may record this Release of Security Interests in Trademarks in the USPTO and in any other offices as may be necessary to carry out the intention of this release, and to the extent applicable, the parties hereto authorize and request that the USPTO record this release of security interest.

Delivery of an executed signature page to this Release of Security Interest in Trademarks by facsimile or electronic transmission (including .pdf file) shall be effective as delivery of an original signature.


