FINAL JUDGMENT ORDER

This matter coming before the Court, all parties having notice and the Court being fully advised in the premises, the Court finds as follows:

1. On May 14, 2015, this Court struck the Counterclaim of Defendant/Third-Party Defendant/Counter-Plaintiff Scala's Original Beef and Sausage Company, LLC ("Scala's Original") and entered an Order of Default against Scala's Original with regard to Plaintiff/Third-Party Defendant, Scala Packing Company, Inc.'s ("Scala Packing") Verified Complaint at Law and with regard to Intervenor/Third-Party Plaintiff, Best Chicago Meat Company, LLC's ("Best Chicago") Verified Third-Party Complaint;

2. On October 30, 2015, this Court entered summary judgment against Scala Packing on Count III of Best Chicago's Verified Third-Party Complaint;
3. On October 30, 2015, this Court dismissed with prejudice Scala Packing's Rescission claim in Count II of Scala Packing's Verified Complaint at Law;
4. On October 30, 2015, Scala Packing voluntarily dismissed Count I of its Verified Complaint at Law;
5. Scala's Original is presently listed as the owner of certain trademark registrations with the United States Patent and Trademark Office pertaining to the mark SCALA'S ORIGINAL, including without limitation, Registration Nos. 4,132,524, 4,044,459, and 4,044,461.

WHEREFORE, IT IS HEREBY ORDERED AND DECLARED THAT:

1. Default judgment is hereby entered in favor of Best Chicago against Scala's Original on all three counts of Best Chicago's Verified Third-Party Complaint;
2. A money judgment is entered in favor of Best Chicago and against Scala's Original in the amount of \$708,714.61, which consists of \$350,000 in principal under the promissory Note, plus \$120,820.28 in interest, plus \$237,894.33 in attorneys' fees and costs;
3. Best Chicago is granted an order of foreclosure against all of Scala Packing and Scala's Original trademarks, trade names, logos, service marks, brand marks, brand names, along with all good will relating to the Trademarks, including but not limited to SCALA'S PREFERRED, SCALA'S ORIGINAL, and the trademarks registered with the United States Patent and Trademark Office as Registration Nos. 3,500,974, 4,132,524, 4,044,459, and 4,044,461 (collectively, the "Trademarks");
4. Best Chicago shall have the right to sell the Trademarks at a public sale; and

5. All claims in this matter having been disposed of, this Final Judgment Order is final and appealable.

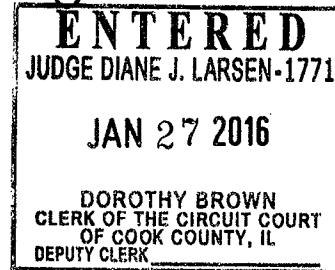
